	Sustainable economic inclusion for forcibly displaced people: Lessons from recent experience

Over the past decade, the number of forcibly displaced people (FDPs) has continued to rise year on year, to about 122 million by mid 2024. Other forms of displacement, linked to climate change and natural disasters, are also on the rise. In both cases, people increasingly live in protracted, long-term displacement situations (including an estimated 75% of FDPs. It is therefore critical to provide them with sustainable livelihoods where they stay to avert long-term dependence on humanitarian aid and reduce pressures to move on to third countries.

This session will explore the lessons from a growing body of experience that systemic approaches are effective in empowering and including forcibly displaced people in local economies.

II-A Finance and (peace) investment in fragile contexts: What does it take?

Mobilising private finance is imperative to achieve SDGs, in particular in fragile situations and in the wider context of declining ODA budgets. While efforts have been growing to mobilise finance and investment, including in ways that do no harm or have a positive effect on peace, widespread success still remains elusive. This session explores practical examples and experiences by leading actors in this space to reflect on 'what works' as well as structural barriers that need to be addressed to unlock finance and investment in fragile contexts.

II-B Enhancing synergies between humanitarian and economic development actors – Organisational obstacles and ways to overcome them

In fragile and conflict affected settings humanitarian aid and systemic development are often both needed: one provides an essential first safety net while the other helps to reduce long-term dependence on the same. This session shares lessons learned from organisations and programs who have invested in approaches, local teams and management processes to successfully deliver both and create sustainable development outcomes in the harshest of conditions.


