09:00 – 10:30	<p>Gender and a Just Transition Towards Environmentally Sustainable Economies and Societies for All</p> <ul style="list-style-type: none"> - <i>Joint session with the DCED Women’s Economic Empowerment Working Group</i> - Following an introduction to the concept of a just transition from Mette Grangaard Lund (ILO, GGWG Chair), we welcome Emanuela Pozzan, Senior Gender Equality Specialist at the ILO, to present the ILO’s work on gender, labour and a just transition. Emanuela will take participants through an overview of the opportunities presented by taking a gender-transformative approach to planning for the future of green jobs. This will include a focus on practical evidence and case studies, particularly from the care sector. 12:00 – 12:45	<p>Implications of New Environmental Regulations</p> <ul style="list-style-type: none"> - <i>Joint session with the DCED Business Environment Working Group</i> - Environmental regulation is becoming increasingly common at regional and global levels (e.g., EU). How do governments and firms respond to these changes? The BEWG are beginning new work exploring the effects of new regional and global environmental regulations on the data requirements of governments and businesses and the business regulatory environment more broadly. This session will discuss the topic, and directions for the work item.
